MARCH 2010 BOARD MEETING

- I. CALL TO ORDER OF BOARD MEETING Pete called the Meeting to order at 7:30.
- II. APPROVAL OF MINUTES All preceding minutes were approved by email prior to the meeting. Kevin will have them all posted to the Website within the next few days.
- III. OPEN FORUM FOR HOMEOWNERS: Mr. Bednar asked to speak about SHHA sponsored Yard Sales.

Mr. Bednar wants the association to continue sponsoring yards sales twice a year and came to the meeting to make the following points:

- Advertising in the Washington Post is critical to success
- Less notice is better. He believes we have advertised too early and people forget about it before it happens
- Rescheduling for weather is a waste of time
